



PRIVACY POLICY – GIFT CARD

USE OF YOUR PERSONAL INFORMATION BY US

The information provided by you from time to time in connection with our gift card, as well as information about your transactions and redemptions, and any information captured whenever you use your Fat Bastard Burrito Co. gift card at a participating Fat Bastard Burrito Co. restaurant, is required by The Fat Bastard Franchise Group Inc., its subsidiaries and affiliates (collectively, "FBFG") to administer, maintain the accuracy of your information, and provide you with advertisements, coupons, or other promotional information. Your personal information will not be used without your consent for purposes other than those for which it was collected and for those stated in this privacy policy. Upon your request, we will provide you with access to the personal information that we have collected about you.

USE OF YOUR PERSONAL INFORMATION BY THIRD PARTIES

We may share your personal information with service providers who perform services on our behalf, including, for example, those who handle the processing of payments relating to the Program. Those persons will be permitted to access only the personal information necessary to provide their services, and they will be prohibited from using your personal information for any other purpose, regardless of what their own privacy policy states. They will also be required to maintain the confidentiality of all personal information that they receive from us. We reserve the right to disclose your personal information if required to do so by law, or in the good-faith belief that such action is reasonably necessary to comply with legal process, respond to claims, or protect the rights, property or safety of our company, employees, customers, or the public.

By participating, you consent to our collection, use and disclosure of your personal information for the purpose stated in this privacy policy, unless you notify us otherwise.

TERMS AND CONDITIONS – GIFT CARD

The following terms and conditions are applicable to the Fat Bastard Burrito Co. gift card.

Gift Card

The gift card is redeemable at any participating Fat Bastard Burrito Co. location in Canada, for all products at the store and it is not valid online.

The gift card is non-refundable and cannot be redeemed for cash (except in those jurisdictions that require redemption for cash). Dollar values on gift cards are non transferable to other gift cards. If found, please return the gift card to The Fat Bastard Franchise Group Inc. at: 3583 Sheppard Ave. East # 360 Toronto, ON, M1T 3K8.

The gift card does not expire. When the balance runs out, you can reload it.

The value of the gift card is in Canadian dollars.

If the value of the gift card is insufficient to cover the cost of the purchase, the balance should be paid with another payment method.

If the gift card is lost or stolen, you can request a replacement gift card, on condition that you provide the original receipt for the gift card purchase and the number of the lost or stolen gift card. A replacement gift card will be activated in the amount of the available balance of the gift card at the time it is being replaced.

You are responsible for all transactions associated with your gift card, whether authorized or unauthorized. You should, therefore, safeguard your gift card. Your purchase of products at participating Fat Bastard Burrito Co. locations constitutes acceptance of these terms and conditions.
