Fat Bastard Burrito Co.'s Privacy Policy is in compliance with the Personal Information Protection and Electronic Documents Act ("PIPEDA") and the Data Protection Act.

1. ACCOUNTABILITY

Fat Bastard Burrito Co. is accountable for the personal information we collect about you. We are committed to ensuring that we comply with our Privacy Guidelines and these Privacy Principles whenever Fat Bastard Burrito collects and uses personal information.

2. IDENTIFYING PURPOSES

Fat Bastard Burrito Co. only collects personal information for business activities. By way of example, we collect information from customers when they participate in a contest, or when they send us comments about the business. 3. CONSENT

4. LIMITED COLLECTION

5. LIMITED USE, DISCLOSURE AND RETENTION

Fat Bastard Burrito Co. will only use your personal information with your knowledge, and will not disclose said information to any agents or others acting on your behalf without your consent. Personal information that is no longer required for specific purposes will be destroyed. If in the course of managing its business operations, Fat Bastard Burrito Co. shares your personal information with professional advisors, franchisees, suppliers, any such entities shall be required to comply with Fat Bastard Burrito Co.'s Privacy Guidelines. Fat Bastard Burrito Co. does not sell or disclose personal information outside of its system.
